Additional Notes

Naming conventions are REQUIRED for all buyW&M requisitions and direct pay requests, Chrome River pre-approvals/expense reports, SPCC charges, EPAF's, and ATG orders.

Any submissions without proper naming convention details will be returned for correction -- see examples below.

BuyW&M requisitions for Apple computer orders

Enter the 4-letter department abbreviation, individual name, DO (for Dean's Office) and iMac or MACB in the Expense ID cell (Example: **GOVT LastName DO iMac** or **GOVT LastName DO MacB**)

BuyW&M requisitions and direct pay requests

In the buyW&M requisition screen about midway down the form along the left column is the **Internal Notes and Attachments** section. The **Expense ID** field is the last line. This is where naming conventions should be entered. See snippet below. This field will hold up to 50 characters. In Qlik this information is populated in the buyW&M Description field in the Transaction Detail Sheet.

BuyW&M direct payment requests

In the buyW&M direct payment form screen in 'Questions - Check Request Information' about midway down the form is the **Payment Description** field. This is where naming conventions should be entered. See snippet below. In Qlik this information is populated in the transaction description field in the Transaction Detail Sheet.

- When submitting JV's, please provide a detailed explanation/purpose for the transfer. If an expense is tied to a specific individual/dept, be sure to include the last name with department abbreviation and the reason for the transfer. This will inform the Dean's office (and other units) and will prevent delays in approval routing.
 - Reminder: Expenses allocated to local funds (private gifts) *cannot* be JV'd to E&G funds.

William & Mary Foundation Indexes

- 2W and 1W indexes were set up to receive reimbursements from the W&M Foundation only
 - If an entity other than WMF is providing funding for an expense, the expense can't be allocated to a 2W index. Only expenses covered by WMF should be allocated to a 2W**** index.

EPAF Approval Routing Guidance -- Arts & Sciences

NOTE: Unit Chairs/Directors must always be added to approval routing as **Approver** for the department/program (Dept Level - Chair / Dept Head, 20)

For grant funded EPAF payments, be sure to include the grant's Principal Investigator (Supervisor / PI, 10) and designated OSP Administrator (OSP prior to unit review, 30) as **Approvers**

- **Approver** for A&S (Unit Level - Fin & Admin, 38) -- Chasity Roberts
- **FYI** for A&S (Unit Level - Fin & Admin, 38) -- Kori Varner and Sherri Powers

Additional guidance for undergraduate student EPAF's...

- Only include A&S Dean's Office staff in the EPAF approval routing **IF** the student's wages will be allocated to any type of Dean's Office funding, i.e., Professorships, Start-Up, Dean Support Index, Summer School (120080) or Faculty Grant Funds. If a student EPAF will be charged to departmental or grant funds, no need to include A&S Dean's Office staff in the approvals routing.
- Provide an explanation as a comment before submitting the EPAF -- the explanation must include the total amount, for example: *[Faculty member name] Faculty Grant Fund award \$XXX_semester and year.*
- Include max budget amount for student's wages, for A&S reference.
