### BA in Computer Science

Proposal indicates that this will allow the department to more quickly add courses that could count as electives. Some may be added later to the permanent catalog.

Concern about this being unclear for the students, may make it difficult to advise and difficult for students to plan.

Proposal could help allow topics courses to be used as electives since these rotate and would not be permanently noted in the catalog. The catalog is also not entirely accurate as many courses listed are actually no longer offered thus adding to problems for student planning just based on the catalog. The new proposal offers more flexibility.

Questions about whether this bypasses EPC or the normal process for a course substitution. May be less of an issue because these are electives not part of the core requirements. Advisor/department acts as the gatekeeper for what counts towards the major.

There are a handful of departments that already do this in principle but the language in the catalog is not uniform.

In this particular case, only 9 electives (~3 courses) would be from outside the department.

Suggestion that, if approved, the language be adjusted to be more consistent with other departments/programs.

\*This raised two important questions – When does EPC apply rules backwards? When should departments be required to update their standards/curriculum to meet current expectations?

### DATA 498 Internship

EPC did not feel the proposal met the criteria for internship and specifically did not outline the scholarly product/component. Brennan will communicate with DATA regarding potential changes.

Brief discussion about the value of tracks/concentrations. These are internal and not external (i.e. not of concern for SCHEV or SACSCOC). Creates some pros and cons for tracking for the registrar's office. Helps with marketing. Students seem to prefer the identity and "extra credentialing."

GOVT 391

Proposal does not seem to meet the criteria for C300.

This proposal was **tabled**. Recommend they go back to CLA to discuss how this course meets C300.

MUSC 363

This proposal was already approved for C350 now requesting C200 for this particular course/topic. Should be indicated as a topics course and the topic is non-repeatable. Cory will work on getting the numbers sorted out.
