- When renting a vehicle for official W&M business purposes, departments may use Enterprise or National rental agencies. National offers airport rental locations, Enterprise offers non-airport locations.
- Discounted rates may be extended to W&M guests and employees for personal use using ID#: 21A6661, pin: WMP. Business rental IDs may not be used for guests or personal use.
- All accidents and damages occurring with rental vehicles must be reported to Risk Management.
