To host a Student Assembly sponsored event providing hot drinks & snacks on the first day of classes of Spring 2022, bringing warmth and excitement to the first day of the new semester

## The Warm Welcome Back Act

WHEREAS, Student Assembly will sponsor an event that will engage the community in a positive and informal setting to foster good relationships going into the new semester. The event will take place January 26th, 2022, which is the first day of classes in the spring semester;

WHEREAS, Student Assembly should be actively engaging the community and providing support as well as resources to students during sponsored events;

WHEREAS, we hope to engage 200-300 students at Sadler Terrance during the first day of class from 12 pm-2 pm;

WHEREAS, hot drinks and delicious snacks during wintertime always brings a smile to the faces of students. All food and drinks items will be catered from Aromas to support a local business in the Williamsburg area. Moreover, Aromas is a student favorite across the William and Mary campus;

WHEREAS, all drinks and snacks will be labeled to allow students with dietary restrictions to make informed decisions on the offered food and drink items;

WHEREAS, the members of Student Assembly who are tabling can provide students with their respective pronoun pins in coordination with the already passed Senate Bill 329-018: The Pronoun Pin Part 2 Act. As well as pass out the informational cards from the Student's Rights Initiative underneath The Plan during this time.

Now, therefore, be it

RESOLVED, that the Student Assembly of William & Mary:

- 1. Charges the sponsors of the bill with executing and planning this event in conjunction with the Department of Student Life.
  - a. Including but not limited to staffing the event, posting a <u>sign-up sheet</u> for tabling, pouring drinks and passing out snacks and the pronoun pins and SRI Info Cards, and cleaning up after the event.
  - b. Charges the Department of Outreach with promoting the event on Student Assembly social media accounts, and creating a flyer that can be printed and posted on social media.
  - c. Charges the Student Life and Outreach committees to participate in the staffing or the promotion of the event, whether that be through hanging posters or posting continuously on social media about the sponsored event utilizing the online posters created by the Department of Outreach.
- 2. Allocates \$807 from the Student Assembly Reserves for the event drinks and snacks;
  - a. \$ 500 for Hot Chocolate & Hot Apple Cider
  - b. \$300 for Cookie and Pastry Trays
  - c. \$7 for one poster to be placed in the Student Assembly A-frame to go on Sadler terrace and other 8"x11" posters to be posted around campus.
- 3. Stipulates that all unused funds be returned to the Student Assembly Reserves.
