

**Matoaka Wellness ‘N Chill Act**

An Act of the 329th Student Assembly of William & Mary,

Sponsored by Senator Regina Chaillo (‘25), Senator Matthew Hwang (‘25), President Yannie Chang (‘25)

Supported by Senator Sean Nguyen (‘25) and Hashir Aqeel (‘25)

WHEREAS, the College of William and Mary is a high stress environment, and mental health is a campus wide issue;

WHEREAS, the student activities fee is FOR THE STUDENTS;

WHEREAS, it is our responsibility as the Senate to find ways to ease academic stress by planning fun events that students can enjoy;

WHEREAS, this is a new and fun way for students to let loose and create new memories on campus with their peers;

WHEREAS, arts and crafts, live music, and outdoor activities are common stress-relievers;

WHEREAS, the resources available on campus, such as the Tribe Truck and the Boathouse, should be utilized in ways that serve the community;

WHEREAS, in the 2021-2022 school year there has not yet been an event at this scale, organized by Student Assembly, that is specifically directed towards school-wide unity;

WHEREAS, the importance of a school-wide unity and mental-health aimed event is well-worth the estimated low cost;

WHEREAS, the estimated cost as compared to previous Student Assembly sponsored events of this scale are much lower;

WHEREAS, Halcyon Lane is a student-made band and it is our responsibility to support students of the College and incorporate them into our Wellness initiatives;

WHEREAS, the Matoaka Wellness 'N Chill Event will be held tentatively on April 16th, 2022;

WHEREAS, the event will be set up to last approximately 3 hours with the band playing 2.5 hours.

Now, therefore, be it

RESOLVED, that the 329th Student Assembly of William & Mary:

1. Allocate \$325-\$1,825 from the Student Assembly Reserves to pay for:
  - a. Music (\$0- \$500),
  - b. Boathouse (\$0-\$500)
  - c. Food (\$0-500)
    - i. Tribe truck
      1. If not possible, Snacks/Refreshments
  - d. [Flyers](#) (\$25)
  - e. Arts and Crafts (\$300)
2. Allocate the Class of 2025 budget for refreshments and entertainment which shall include:
  - a. Martha Wren Briggs Amphitheater at Lake Matoaka Rental (\$50 per hr, \$150 total)
3. Charges the members of the Senate of Student Assembly to promote this event through sharing posts advertising the Matoaka Wellness 'N Chill on Instagram and other channels of social media, as well as charging Class Presidents with advertising this event in class emails.
4. Stipulates that all unused funds go back to the Student Assembly Reserves and the Class of 2025 budget
