The Tribe Spirit Act

WHEREAS, it is a tradition of the Student Assembly to sell Homecoming Shirts. Although this year these shirts will be sold during W&M family weekend and Homecoming, which allows Student Assembly to make the most returns on its investment;

WHEREAS, Student Assembly is already in the planning stages with Tribe Athletics and Student Unions and Engagement to have a family weekend tailgate party. So, by using this new relationship Student Assembly can promote community bonding and Tribe pride;

WHEREAS, conducting fundraising is the only way for Student Assembly to replenish its Off-Campus Account, which supports vital internal operations;

WHEREAS, Family Weekend is a tradition of William & Mary and it allows families and friends of students to bond, explore campus, and dive into tribe spirit. Homecoming is a long-standing tradition at William & Mary in which alumni and students come together to celebrate the school and their time at the College;

WHEREAS, Homecoming and Family Weekend are times for students to unite and promote a sense of community and belonging within the William & Mary community;

WHEREAS, 2021 Homecoming Tshirt Sales did not excel as projected based on 2020 shirt sales, we have reduced the amount of shirts to purchase for 2022 to 250 (and combining shirt sales with a weekend where parents and families could be interested in purchasing/paying for shirts will help accelerate sales);

WHEREAS, as student life continues to grow and thrive on campus, it is important that we continue to have this critical Student Assembly Tradition.

Now, therefore, be it,

RESOLVED, that the Student Assembly of William & Mary,

1. Allocates up to \$2500 from the Student Assembly Reserves for the purchasing of homecoming shirts.
2. Charges the Department of Outreach with the advertisement of the selling (including pre-sale reservations) of the t-shirts
3. Charges Department of Student Life with coordination of selling times, and charges the Executive Branch and Senate with facilitating sales during Family Weekend and Homecoming
4. Stipulates that all unused funds be returned to the Student Assembly Reserves and that revenue earned from t-shirt sales be deposited into the Student Assembly Off-Campus Account.
